NOTE – To be re-certified, it is necessary to gain a minimum of 30 points in a 5-year period. A maximum of 10 points per year will be allowed.			

**Notes:**

1. Reference letter(s) from the employer should give the details about period of employment, the level of responsibilities, years of experience and type of jobs carried out in each method, such as writing procedure, carrying out NDT, supervising, preparing reports, analysis of results, interaction with purchaser/designer, training personal etc. It should be on the company letterhead, clearly indicating the name and designation of the official issuing the letter. Application may be rejected in case all the details are not given. These letters should cover complete five-year period.
2. If the applicant has changed the employment after passing the examination, separate letters are required from each employer.
3. In case of self-employed applicant, reference letter may be obtained from two or more of his clients. These letters should clearly bring out details about applicant's experience, level of responsibility and type of jobs carried out in each of the method during last five years.
4. Application fee is as shown below:
  - a. Rs.1500/- for one sector of a method and Rs. 500/- for every additional method/sector. Plus Service Tax as applicable. (at present -12.36%)
5. Application fee is non-refundable.

### **Extracts from BIS Standards Vision Requirements**

The candidate shall provide documented evidence of satisfactory vision, in accordance with the following requirements,

a) Distance vision shall equal smaller fraction 20 / 30 or better in atleast one eye, either uncorrected or corrected.

b) Near vision shall permit reading a minimum of Jaeger number 2 or equivalent type and size letters at not less than 80cms. on a standard Jaeger test chart for near vision, in atleast one eye, corrected or uncorrected.

c) Colour vision shall be sufficient that the candidate can distinguish and differentiate between the colours used in the NDT method concerned and colour vision to be tested as per ISHIHARAS Charts.
